#### **Abstract**

This research aims to analyze the implementation of religious moderation at the Al-Hadi Pekalongan Islamic Boarding School as a response to stigmatization and rejection of Shia beliefs. Using Seyyed Hossein Nasr's theoretical framework which emphasizes balance (*tawazun*), justice (*'adl*), and wisdom (*hikmah*), this research adopts a qualitative method with a case study. This approach involves in-depth interviews, observation, and document analysis. The research results show that the integration of religious moderation teachings in the Islamic boarding school curriculum has succeeded in encouraging tolerant attitudes and constructive

political participation, making Al-Hadi Islamic Boarding School a model of religious moderation in Indonesia.

### Introduction

The stigmatization and rejection of the Shia belief by society have created a situation where adherents of the Ahlul Bayt sect often feel the need to conceal their faith, known as tagiyyah, as a preventive measure against potential violence or discrimination.<sup>1</sup> Amidst this dynamic, Pesantren Al-Hadi in Pekalongan focuses on a middle-path approach in religious contexts. As a traditional Islamic educational institution, pesantren plays a significant role in shaping religious thought and practices among Indonesian Muslims.<sup>2</sup> Among the various pesantren, Pesantren Ahlul Bayt Al-Hadi in Pekalongan stands out for promoting religious moderation and responsible political participation. This pesantren aims to promote religious moderation by emphasizing moral exemplarity in all aspects of its activities while being open to the surrounding community. However, beyond objective issues such as power and bureaucracy in the context of religious moderation, there are also subjective issues related to political views on the Ahlul Bayt sect.<sup>3</sup>

In a global context filled with political and religious dynamics, religious moderation has become an increasingly important theme in efforts to maintain social stability and avoid potentially destructive conflicts. In Indonesia, as the country with the largest Muslim population in the world, the issue of religious moderation is not only a theoretical question but also practically relevant in the daily lives of its citizens. This research explores these dynamics within the context of the sociology of religion, examining how Pesantren Al-Hadi addresses the challenges of stigmatization and rejection of Shia beliefs and how it seeks to apply a middle-path political approach to promote religious moderation. Using qualitative research methods and integrating the principles of Seyved Hossein Nasr's sociology of religion, the middle-path approach in religion and politics is expected to provide deep insights into how this concept can be applied in daily life and offer solutions to the challenges faced by Muslim communities, especially those adhering to the Ahlul Bayt sect.

Through this study, we aim to gain a deeper understanding of the relationship between religious moderation, Islamic philosophy, and political participation at Pesantren Ahlul Bayt Al-Hadi. The findings of this research illustrate how Seyyed Hossein Nasr's views on religious moderation, Islamic philosophy, and political participation are reflected in the practices and approaches adopted by Pesantren Ahlul Bayt Al-Hadi. This highlights the importance of a holistic and integrated approach in understanding and addressing religious and political challenges in society.

So, the formulation of the problem are (1) how does the Al Hadi Pekalongan Islamic Boarding School implement religious and political moderation based on the principles of the sociology of religion? (2) How do the principles of the sociology of religion

according to Sayyed Hossein Nasr's views influence religious practice and political participation at the Al Hadi Pekalongan Islamic Boarding School?

#### Result and Discussion

## Religious Moderation in Al Hadi Pekalongan Islamic Boarding School

Al Hadi Pekalongan Islamic Boarding School shows a strong commitment to the practice of religious and political moderation.<sup>4</sup> This is reflected in the integration of religious values with the values of tolerance, justice and responsible political participation. This commitment may be reflected in various aspects of Islamic boarding school life, from the educational curriculum to organizational culture.

The principles of sociology of religion according to Sayyed Hossein Nasr may be the main guide in implementing religious moderation in Islamic boarding schools. Nasr's emphasis on a deep understanding of religion as a source of values — and moral guidance can help Islamic boarding schools in forming a balanced and harmonious attitude towards various aspects of life.<sup>5</sup>

The main challenges facing Islamic boarding schools may be related to stigmatization and rejection of Shia beliefs. The impact of this stigmatization can be very significant, including creating

It is important to evaluate the impact of implementing religious and political moderation in Islamic boarding schools, both in terms of the character of the Islamic boarding school itself and its contribution to wider society. This can include an evaluation of the character formation of students, inter-religious relations in the Islamic boarding school environment, as well as the role of Islamic boarding schools in promoting tolerance and peace in society.

The Ahlul Bayt Al Hadi Pekalongan Islamic Boarding School implements religious and political moderation through various steps and activities that are well integrated into the education system and daily practices. Islamic boarding schools design curricula that include not only religious aspects, but also moderate values

such as tolerance, justice and responsible political participation. This ensures that students not only learn about religious teachings, but are also taught to respect differences and contribute positively to society.

The stigmatization of ideological political views against Shiites has a broad impact, including creating horizontal conflict in

society.<sup>7</sup> The influence of ideological political views is the MUI fatwa in 1984 and the decision of the MUI National Working Meeting forum in 2007. This fatwa and the forum's decision directly or indirectly lead to the public's perception that Shia beliefs are considered heretical or deviate from the true teachings of Islam.

The challenges faced by Al Hadi Islamic Boarding School, related to stigmatization and rejection of Shia beliefs, are complex and significant issues. Stigmatization of Shia beliefs is often triggered by ideological political views that negatively influence society's perception of Shia beliefs. The impact can be widespread, including creating horizontal conflict in society which can disrupt social stability and harmony between religious communities.

In this context, Sayyed Hossein Nasr's perspective on the sociology of religion can provide valuable insights. Nasr emphasized the importance of understanding religion not only as a social phenomenon, but also as a window to the transcendental dimension of human life. This view highlights that religion has a very important role in shaping the values, norms and life orientation of individuals and society as a whole.

By understanding religion holistically as taught by Nasr, Al Hadi Islamic Boarding School can face the challenge of stigmatization of Shia beliefs with a broader and more inclusive approach. They can seek to promote a deep understanding of the Shiite faith as part of the diversity within the Islamic tradition, while teaching the values of moderation, tolerance, and unity.

Another thing in Nasr's approach which emphasizes respect for diversity and plurality in religion can also help Islamic boarding

schools to build constructive dialogue with the wider community, including those who may have different views or beliefs. In this way, Islamic boarding schools can act as agents of positive change in overcoming stigmatization and rejection of Shia beliefs, as well as promoting peace and harmony between religious communities.<sup>8</sup>

The Al Hadi Pekalongan Islamic Boarding School is based on the Ahlul Bayt school of thought which refers to various existing regulations and regulations to ensure that their religious practices are in accordance with Islamic teachings and the principles of moderation. Several regulations and regulations serve as a reference for Ahlul Bayt Islamic boarding schools in implementing religious moderation based on the regulations of the Minister of Religion Regulations regarding Islamic Boarding Schools: Islamic boarding schools can refer to regulations issued by the Ministry of Religion regarding governance, curriculum and religious practices in Islamic boarding schools.

However, sometimes there is a paradox where the fatwa issued is not always in line with the principle of moderation or can even conflict with the views held by a particular Islamic boarding school.

In the context of Ahlul Bayt Islamic boarding schools, characterized by their emphasis on moderation and tolerance, fatwas issued by religious authorities require meticulous scrutiny to ensure alignment with these core values. It is imperative that such religious edicts are harmonized with the principles of justice, inclusivity, and respect for diverse perspectives, fundamental to the Ahlul Bayt tradition.<sup>10</sup>

Paradoxes can emerge when issued fatwas contradict the ethos of moderation cultivated in Ahlul Bayt Islamic boarding schools. For instance, if a fatwa promotes intolerance or discrimination, it directly conflicts with the institution's core values. In such instances, a nuanced and critical evaluation of the fatwa is essential, necessitating a deeper exploration of Islamic moderation to reconcile potential discrepancies and ensure that practices align with the boarding school's principles.

Al Hadi Pekalongan Islamic Boarding School refers to various existing regulations and rules to ensure that their religious practices are in accordance with Islamic teachings and the principles of moderation. Several regulations and rules that can be used as a reference for Ahlul Bayt Islamic boarding schools in implementing religious moderation include; relations of religious moderation in Shia Islamic boarding schools which are related to Presidential Regulation (Perpres) Number 58 of 2023 concerning Strengthening Religious Moderation which is in line with Article 4 paragraph (1) of

the 1945 Constitution of the Republic of Indonesia. Furthermore, moderation is strengthened with derivative regulations of the Ministerial Regulation Religion No. 3 of 2024 includes several important aspects:

Islamic boarding schools as Islamic educational institutions have an important role in spreading Islamic values to the surrounding community. Through dakwah activities, Islamic boarding schools can provide a better understanding of Islamic teachings and make a positive contribution to the spiritual and social development of society. <sup>11</sup>

Delivering dakwah messages accurately and easily understood. This can be done by inviting the community and government such as the village head or sub-district head, the Pekalongan Ministry of Religion office, or the religious affairs office (KUA) to public events with lectures, recitations, social activities and social media. As part of opening up space for Monitoring and Evaluation. This needs to be done with the development of Islamic boarding schools to ensure that dakwah and educational activities are carried out in accordance with established standards and principles.

In the coordination between the Al Hadi Islamic Boarding School and the Government, in this case the Indonesian Ministry of Religion, through collaboration between the Islamic boarding school and the Indonesian Ministry of Religion, it is important to coordinate various religious activities, develop the Islamic boarding school curriculum, as well as fulfill administrative needs and regulations. This coordination can also help Islamic boarding

This is important to ensure that Islamic boarding schools operate in accordance with the principles of moderation and comply with applicable regulations.<sup>13</sup>

By following the coordination, monitoring, evaluation, and reporting procedures outlined in Ministerial Regulation No. 3 of 2024, Al Hadi Islamic Boarding School can strengthen the implementation of moderate religious values in boarding school life, thus creating an inclusive, tolerant, and harmonious environment for all members of the boarding school. The pesantren can refer to these regulations as a guide in carrying out daily activities and ensuring that the activities carried out are in accordance with the provisions applicable in Indonesia. In addition, complying with these regulations also helps pesantren to improve the quality and standards of religious education that is organized.

Al Hadi Islamic Boarding School Pekalongan can also develop an internal code of ethics and education standards that

Pesantren in Indonesia must operate within the framework of State Laws and Regulations on Freedom of Religion, which

So understanding the Ahlul Bayt school of thought in depth can be the key to revealing the truth and warding off existing misunderstandings.

An in-depth understanding of the Ahlul Bayt school of thought can help in the process of answering the gap in society at the Ahlul Bayt School of Islamic boarding schools such as in the Historical Context, where the Ahlul Bayt School of thought has deep roots in Islamic history, especially related to the life and teachings passed on by the family of the Prophet Muhammad

SAW.<sup>16</sup> By understanding this historical context, we can understand the position, views and contributions of Ahlul Bayt in the development of Islamic teachings.

In the Perfection of Teachings, the Ahlul Bayt School is believed by its followers to hold teachings that are purer and more perfect than Islam. Understanding the teachings taught by Ahlul Bayt can help clarify erroneous understandings and demonstrate the essential truths of Islamic teachings.

Views on Justice and Leadership, that Ahlul Bayt is seen as the main example of justice, leadership and morality in Islam. Understanding their views on these concepts can help in counteracting misunderstandings or distortions about Islam, especially when it comes to managing power and decision making.

According to the author's view, religious communities pay respect to Ahlul Bayt, where respect for Ahlul Bayt is an integral part of our religious beliefs and culture.<sup>17</sup> Understanding the values espoused and the importance of their position in Islam can help build respect and tolerance among Muslims, as well as strengthen Islamic brotherhood as a whole.

Deep knowledge of the Ahlul Bayt school of thought can help counteract narrow or extreme understandings of Islam. By showing the depth and diversity of views that exist within this school of thought, we can counter the narrow narratives used by radical groups to justify their actions.

Encouraging participation in peace and reconciliation initiatives between Sunnis and Shias can help strengthen harmony between Muslims.<sup>18</sup>

It is important to understand that cultural and historical differences also play a role in the formation of a sect's identity. By understanding each other's cultural and historical context, it will be easier to appreciate differences and build harmonious relationships.

Through a holistic and sustainable approach, it is hoped that the negative mindset towards the Ahlul Bayt sect can change towards a more inclusive attitude, mutual respect and peace between Muslims. For Ahlul Bayt Islamic boarding schools such as Al Hadi Islamic Boarding School, this stigmatization is a serious challenge in carrying out religious and educational activities. When faced with rejection by some parts of society or difficulty in getting support and recognition.

to ensure that all citizens have the same right to be respected and recognized.

The principle of equality in Islam emphasizes that all humans have the same dignity before Allah. Therefore, Islamic religious sociology demands equal treatment of all individuals and groups, without distinguishing based on their religious beliefs or religious sects. This means that stigmatization or discrimination against Shia beliefs is not in accordance with the principles of equality taught in Islam.<sup>20</sup>

Islam teaches respect for diversity of beliefs and cultural diversity. In this context, Islamic religious sociology encourages inter-religious dialogue, mutual understanding, and inter-faith cooperation to create an inclusive and harmonious society. Stigmatization of Shia beliefs is a violation of these values, and Islamic religious sociology can be a basis for establishing respect for the plurality of beliefs.<sup>21</sup>

By adopting an Islamic sociological perspective, society can better understand the importance of respecting differences in beliefs, upholding justice and equality, and promoting dialogue between religious believers to create an inclusive and harmonious society.

#### Conclusion

Implementation of a holistic approach that includes religious, social and political aspects. By combining Islamic values with the concept of religious and political moderation, Islamic boarding schools create a comprehensive and sustainable educational environment.
